## Assumption of Risk, Waiver of Liability, and Hold Harmless Agreement

In consideration of my participation in our homeschool co-op weekly meeting I, \_\_\_\_\_, agree to be solely responsible for my own safety and the safety of my children (listed below) and to take very precaution to provide for our safety and well-being while participating in activities located CrossRoads Church or at the directors personal residence, whether at this location (5756 Sweetwater Blvd Port Orange FL 32127) or another location in relation to our group (i.e., Deland Camp, another group members home, field trips or get togethers). I understand and agree that I am responsible for my children's supervision, actions, and resulting consequences of their actions during time in which they are on any premises as a participant with our meeting/gathering. In the event of injuries to my children or myself, I agree to assume full responsibility for their medical care, attention and any resulting medical expenses.

I, \_\_\_\_\_, am fully aware of the risks and hazards connected with visiting and possibly handling of farm-related animals and equipment. I voluntarily assume full responsibility for risks taken by me when visiting the directors home or any other location with the group. I voluntarily assume full responsibility for any risk of property damage, personal injury, including death, that may be sustained to me or to any loss or damage to any property owned by me, as a result of my visit to these locations.

I, \_\_\_\_\_, understand that there is no express or implied warranty that shall apply. I accept any and all costs and or treatments for myself and my family should medical treatments of any kind be needed by me or by my family as a result of my (our) visit to these locations.

I, \_\_\_\_\_, further hereby agree to identify and hold harmless the owners of these locations for any reason whatsoever during my visit to these locations.

I, \_\_\_\_\_, understand there is a swimming pool at one of these locations. There are no security measures around said pool and I assume all responsibility for keeping my child(ren) away from and safe from said pool. I recognize and understand that playing at or in the swimming pool involves certain risks. Those risks include, but are not limited to, the risk of injury resulting from possible malfunction of the equipment used in the pool and injuries resulting from tripping or falling over obstacles in the pool area. I agree to release the property owners, MBA, and any other businesses associated with these locations from any and all claims that I have or may have in the future and release them from any and all liability for any loss, damage, injury, death or expense that I, or my family or next of kin, may suffer due to any cause.

It is my express intent that this release agreement shall be for myself and the members of my family and spouse if I am alive and my heirs, assigns and personal representative(s) if I am deceased and shall be deemed as an agreement to release, waive, discharge, covenant not to sue, and indemnify the property owners and/or businesses related to the location.

The student or the student's parents or guardians assume the risk of injury to the student (or themselves) while attending courses, lessons, 4H, PE or any other such activity.

We desire to maintain a healthy environment by proper cleaning methods to prevent the spread of any communicable disease.
